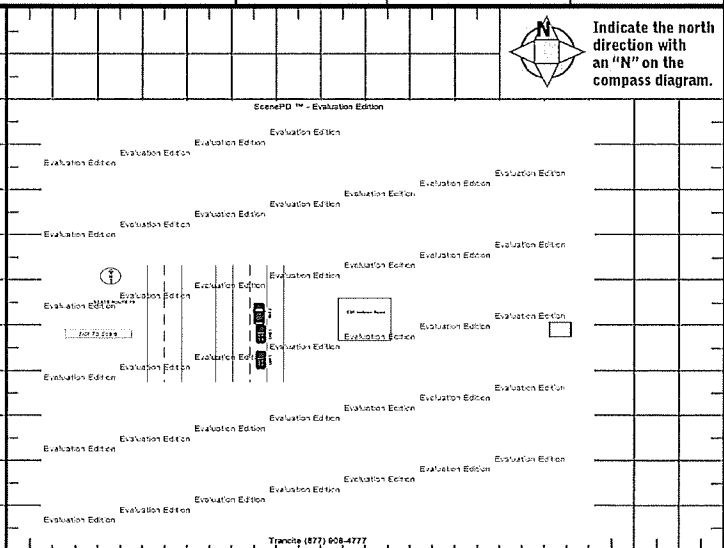

**UNITS #2 AND 1, IN THAT ORDER, WERE NORTHBOUND ON STATE ROUTE 79 IN THE AREA OF 530 HEBRON ROAD. BOTH UNITS WERE STOPPED FOR TRAFFIC. TRAFFIC BEGAN TO MOVE AND BOTH UNITS BEGAN MOVING FORWARD. TRAFFIC AGAIN STOPPED AND UNIT #2 HAD TO STOP FOR TRAFFIC. UNIT #1 FAILED TO MAINTAIN AN ASSURED CLEAR DISTANCE AHEAD AND STRUCK THE REAR OF UNIT #2.**

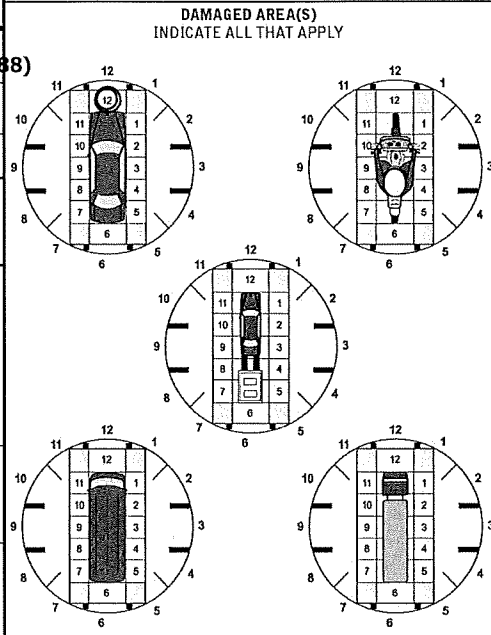
