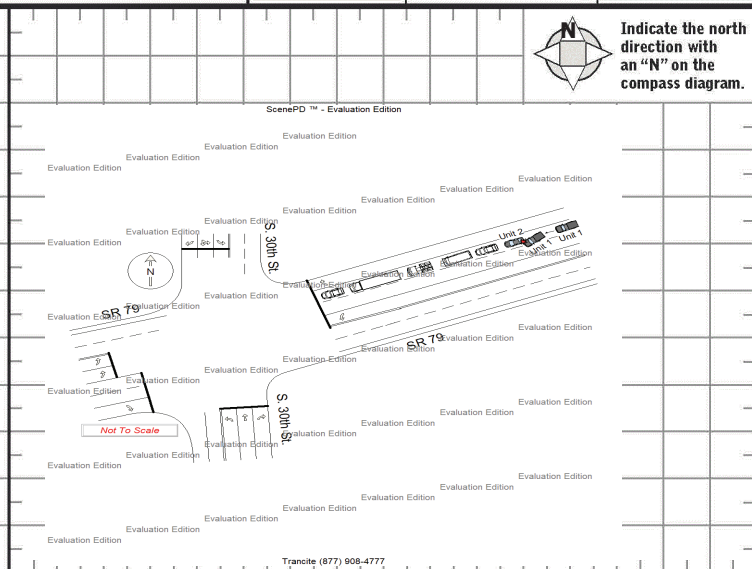

NARRATIVE
 Unit 2 was legally stopped in traffic in the right straight lane of southbound State Route 79, north of South 30th Street. Unit 1 approached Unit 2 from behind in the same lane and in the same direction. Unit 1 did not stop in time, striking Unit 2 in a rear-end collision. Unit 1 attempted to move into the left lane prior to the crash, bus was unsuccessful.

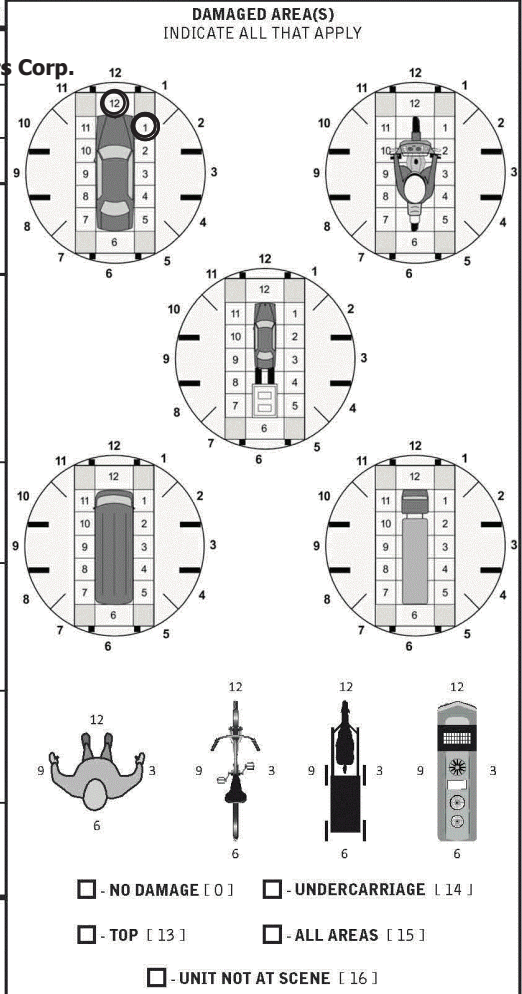

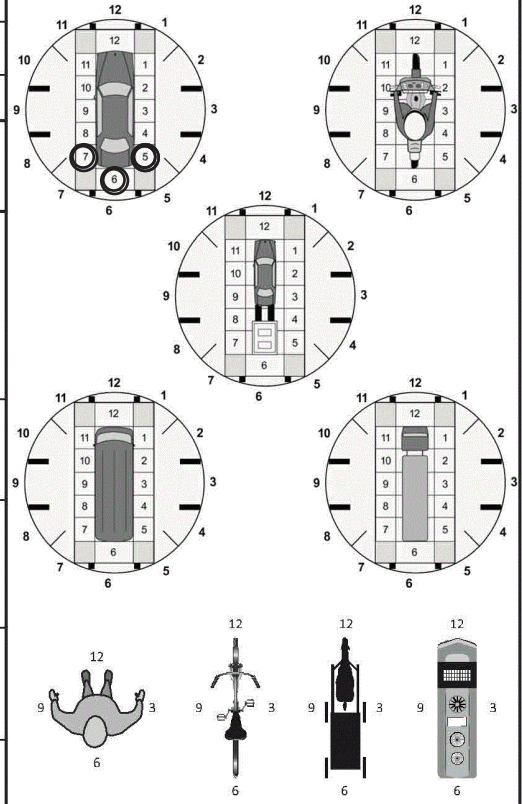
