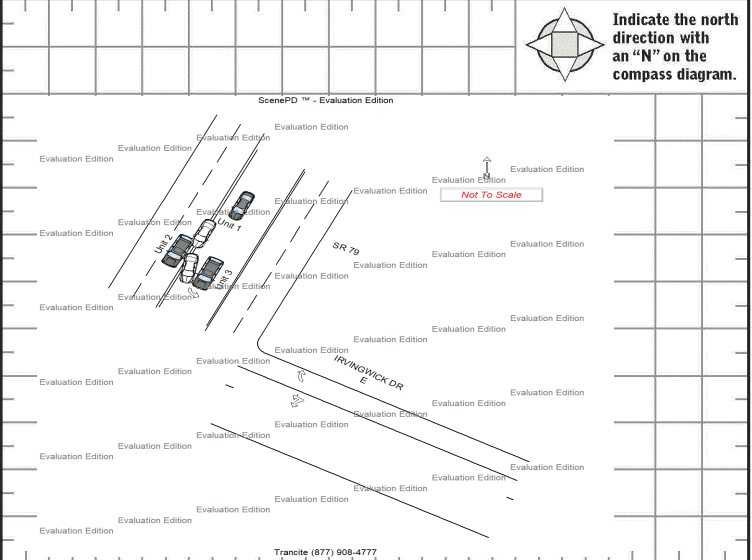

UNIT 1 LOST CONTROL OF THEIR VEHICLE AND ATTEMPTED TO MANEUVER BETWEEN THE TWO VEHICLES. UNIT 1 STRUCK UNIT 2, WHICH PROPELLED UNIT 1 INTO UNIT 3.

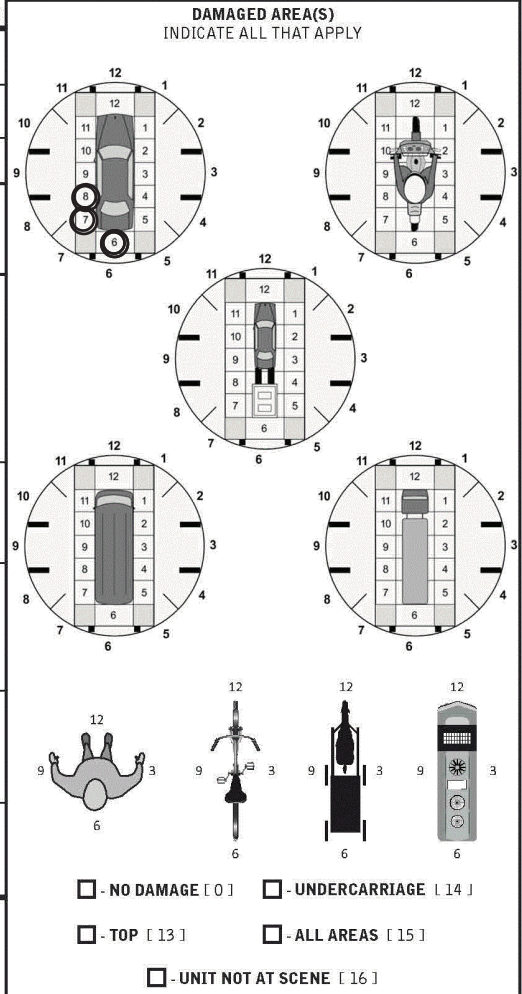
