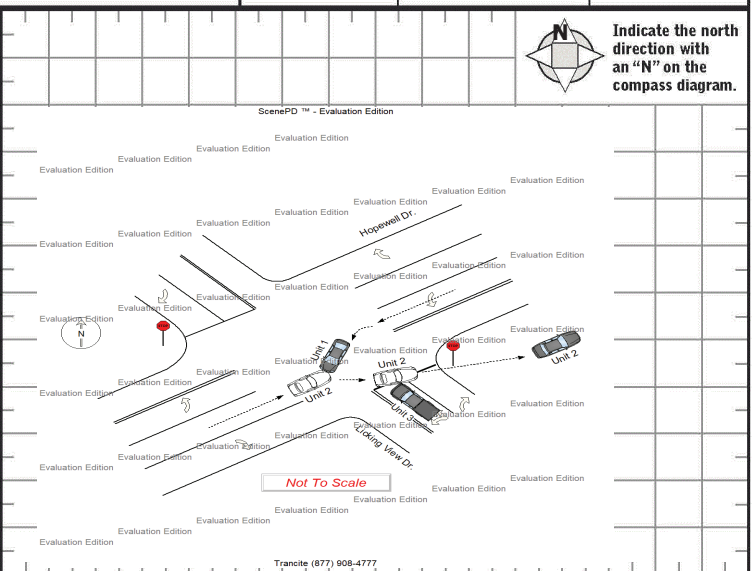

Unit 1 was traveling west on Hopewell Dr. Unit 2 was traveling east on Hopewell Dr. Unit 3 was traveling north on Licking View Dr. and stopped at the stop sign. Unit 1 attempted to turn left onto Licking View Dr. and struck Unit 2. The collision forced Unit 2 to the right and Unit 2 struck the front of Unit 3. Unit 2 went off the right side of the road and struck the stop sign. Unit 2 ended up in the ditch.
