e) Plans drawn to scale showing the actual shape and dimensions of the lot and any existing buildings/accessory building on the lot. The plans should identify the location of any proposed building as well as any alterations to an existing building. The existing and intended use of each building or part of a building, the number of families or housekeeping units the building is designed to accommodate and such other information with regard to the lot and neighboring lots as may be necessary to determine the proper hearing of the application is also required.

f) Each application shall be accompanied by a required payment in the amount of at least \$75.00 for the purposes of defraying the expense of publishing notices in the newspaper and necessary clerical services.
