VICTIM'S BILL OF RIGHTS BT OHIO LAW

Under Ohio's Victim's Rights Law, enacted in October 1994, you have the right to know what is happening with your case, and the right to participate during the criminal justice proceedings in the case. More specifically, you have these rights:

- To be treated with respect and dignity at all times
- To be protected from intimidation
- To be notified of the defendant's name, the offense(s) with which the defendant has been formally charged and the criminal case number
- To be notified of the procedural steps in a criminal prosecution, and to be present during the courtroom proceedings

UPON YOUR REQUEST, you have these additional rights:

- To be informed of the date, time, and location of courtroom proceedings, and any changes in the scheduling of those proceedings
- To be informed of any motion or request that may result in a substantial delay in the case
- To be informed of a change of plea hearing, the conviction of the defendant or of the dismissal of the case
- Upon conviction, to be informed of the date, time, and location of the sentencing hearing
- To provide a Victim Impact Statement for the inclusion in the pre-sentence investigation report prepared by the Adult Court Services Department of the Licking County Municipal Court and the right to make a statement to the Court at any sentencing hearing (oral or written, at the discretion of the Judge) regarding the crime and your opinion regarding the sentence of the offender
- The right to request restitution for medical expenses, loss of income and/or property damage
