HEATH RESIDENTS

IF YOU ARE NEW TO THIS AREA, WE WOULD LIKE TO TAKE THIS OPPORTUNITY TO WELCOME YOU TO THE CITY OF HEATH AND INFORM YOU OF OUR LOCAL CITY INCOME TAX. OUR CURRENT TAX RATE IS 1.5% AND HAS BEEN SINCE 1988. THIS IS AN INCOME TAX THAT IS FIGURED PREDOMINANTLY ON GROSS, EARNED INCOME.

CHAPTER 181 OF THE HEATH CITY CODIFIED ORDINANCES PERTAINS TO THE LOCAL INCOME TAX. WE HAVE, AVAILABLE UPON REQUEST, A COPY OF THE TAX ORDINANCE. SECTION (.10) OF THE TAX ORDINANCE REFERS TO MANDATORY REGISTRATION. THIS MEANS THAT ALL RESIDENTS OF THE CITY ARE REQUIRED TO REGISTER WITH THE INCOME TAX BUREAU. IN ORDER FOR YOU TO DO THIS, YOU NEED TO COMPLETE A RESIDENT REGISTRATION QUESTIONNAIRE AND SUBMIT IT TO OUR OFFICE AS SOON AS POSSIBLE. IF YOU HAVE ANY QUESTIONS ABOUT THE INCOME TAX OR COMPLETING THE RESIDENT REGISTRATION QUESTIONNAIRE, PLEASE DO NOT HESITATE TO CALL **(740-522-3427 EXT. 3)** OR STOP BY OUR OFFICE. WE WILL BE GLAD TO ASSIST YOU.

PLEASE ANSWER ALL QUESTIONS AS ACCURATELY AND COMPLETELY AS POSSIBLE, AS THIS INFORMATION WILL BE USED TO DETERMINE WHETHER OR NOT YOU NEED TO FILE AN INCOME TAX RETURN.

IF YOU ARE REQUIRED TO FILE AN INCOME TAX RETURN WITH OUR OFFICE, YOU MAY GO TO OUR WEBSITE (WWW.HEATHOHIO.GOV) AND DOWNLOAD GENERAL INFORMATION, THE FORMS NEEDED AND THE INSTRUCTIONS FOR COMPLETING THE FORMS. WE WILL ALSO COMPLETE YOUR HEATH TAX RETURNS IN OUR OFFICE, FREE OF CHARGE. WE ACCEPT WALK-INS THROUGH THE END OF MARCH; HOWEVER, *IF YOU WANT TO COME IN APRIL, YOU MUST MAKE AN APPOINTMENT PRIOR TO APRIL.* **PLEASE MAKE NOTE THAT WE DO NOT SCHEDULE ANY APPOINTMENTS FOR APRIL 15TH.**
